# 50 MW Power Plant for K-IV Phase I

### The Assignment

The Local Government Department, Government of Sindh, invited proposals from reputable and experienced firm(s)/consortia to prepare a detailed Feasibility Report as well as sought Transaction Advisory Services for 50 MW Power Project for K-IV Phase I project through an advertisement in Daily Dawn, in Daily Kaawish and in Daily Jang on 24<sup>th</sup> May, 2018.

In this regard, the Local Government Department is issuing an Addendum to the RFP based on the feedback received in the Pre-Bid Meeting & based on additional queries/clarifications from potential parties. Further details including proposed changes in the RFP are provided in the Addendum to the Request for Proposal (RFP).

#### **Brief Scope of Work**

The detailed scope of work for the transaction advisor to develop the project is provided in the RFP. However, briefly, the Transaction Advisor/ Consulting Firm(s) shall be expected to perform at least the following tasks:

- a) Conduct Technical and Financial Feasibility of the proposed project.
- b) Conduct Detailed Legal, and Regulatory Study, PPP options analysis and provide Transaction Advisory Services in respect of the project.
- c) Assist Local Government Department in marketing the project to the interested mix of investors, and administering the bidding process for implementation of the project till achieving Financial Closure.

**Eligibility:** Registration with Sindh Revenue Board (SRB), relevant tax authorities. Further eligibility is mentioned in the RFP document. **Submission of Proposals:** In a sealed envelop as mentioned in the RFP.

**Bid Security:** 1% of Bid Price

**Response Time:** From issuance of bidding documents to 28<sup>th</sup> June 2018.

Bid Submission Deadline: 29th June, 2018 at 11:00 a.m.

**<u>Bid Opening:</u>** Proposals would be opened on 29<sup>th</sup> June, 2018 at 11:30 a.m.
