INVITATION FOR PREQUALIFICATION OF BIDDERS

DESIGN, FINANCE, BUILD, OPERATE, MAINTAIN AND TRANSFER OF TP1 WASTEWATER RECYCLING PROJECT UNDER THE PUBLIC-PRIVATE PARTNERSHIP MODE

PROJECT

Karachi Water and Sewerage Board (the **'KWSB'**), a public sector organization responsible for provision of water and sewerage services in Karachi under Karachi Water & Sewerage Board Act 1996, intends to engage a private party to design, finance, build, operate, maintain and transfer (DFBOMT) the infrastructure and associated facilities of TP1 Wastewater Recycling Project on a public private partnership (PPP) mode to provide 35 MIGD of municipal wastewater treatment and a recycling plant with desalination to utilize 35 MIGD effluent and distribute 28 MIGD high grade industrial water to consumers in Sindh Industrial Trading Estate (SITE), Karachi (the **'Project'**). The KWSB has launched the Project pursuant to an unsolicited proposal received from a private party in accordance with Rule-15(A) of SPP Rules, 2010.

The Project is being implemented as part of Government of Sindh's strategy towards developing Sindh's water infrastructure and amenities. The KWSB has engaged Asian Development Bank, acting through its Office of the Public-Private Partnership, to act as lead transaction advisor in relation to the Project.

PROJECT'S SCOPE

The scope of the Project entails, on a DFBOMT basis:

- 100 MIGD inlet works in the south east corner of TP-1 site;
- 35 MIGD integrated wastewater treatment plant;
- Recycling plant to produce not less than 28 MIGD of high-grade industrial water for consumers, inter alia, with TDS not exceeding 1000 mg/L;
- On-site bypass to the integrated wastewater treatment plant;
- Reverse osmosis concentrate discharge pipeline to Lyari river; and
- Recycled water distribution network within S.I.T.E. designed for 50 MIGD industrial demand and smart consumer metering system.

CONCESSION PERIOD

The Project shall be structured and documented as a 27-years DFBOMT contract, which includes, inter alia, a construction period of up to 2-years. For more specific details of the Project, please refer to the Project's pregualification document (the 'Pregualification Document').

ELIGIBLE BIDDERS

The KWSB invites applications from reputable entities/ private parties (the 'Prospective Bidders') having requisite capabilities, competences, and resources, as further detailed under the Pregualification Document.

PROCUREMENT PROCEDURE

The Project's procurement shall be conducted in accordance with the **International Competitive Bidding** procedure, followed by prequalification and then competitive bidding process, as prescribed under Rules-15(2)(a) & 15(A) of SPP Rules, 2010, and is open to all the eligible Prospective Bidders.
