Neither any of these entities nor their employees, personnel, consultants, advisors, agents, contractors, etc., will be liable to reimburse or compensate the recipient for any costs, fees, damages, or expenses incurred by the recipient in evaluating or acting upon the RFP or otherwise in connection with the Project as contemplated herein.

The Bids (Technical Proposal and Financial Proposal) submitted by any of the prospective Bidders in response to the RFP Document shall be upon the full understanding and agreement of any and all terms of the RFP Document, the Addendum to the RFP Document, and the Response Document (the '**RFP Documents**') and such submission shall be deemed as an acceptance to all the terms and conditions stated in the RFP Documents. ADDENDUM DOCUMENT NO. I

The Authority hereby issues this Addendum to the Request for Proposals document dated 26th June 2024 (the 'Addendum Document No. I') to set out the changes and amendments to the Request for Proposals document, including its content as tabulated under Section 5 (*BIDDING DOCUMENTS*) (the 'RFP Document'), previously circulated in respect of the management and operation of Girls' Elementary Public sector schools under public-private partnership mode – Package 2 (*DISTRICTS: Badin, Hyderabad, Jamshoro & Tando Allahyar*)¹ (the 'Project'), which amendments and changes shall stand incorporated in the RFP Document. Notwithstanding anything to the contrary, all relevant provisions of the RFP Document shall stand amended to the extent required to give effect to the matters set out in this Addendum Document No. I. Except as otherwise expressly set out in this Addendum Document No. I, all other provisions of the RFP Document shall remain unchanged.

The following amendments shall stand incorporated in the RFP Document:

1. Definitions

All capitalized terms not defined herein shall have the meaning set forth in the RFP Document.

Term	Definition
Bid Security	The security deposit that a Bidder must provide in the form of a financial guarantee issued by a scheduled commercial bank operating in Pakistan acceptable to the Government (with a minimum credit rating of 'A-' according to the PACRA or JCR- VIS rating scale for financial institutions), in form and substance as attached hereto as FORM E to ANNEX 2 (FORMS) and in the amounts and conditions specified in Section 6.2.11 (BID SECURITY). It is being clarified that the Bid Security shall not be in the form of an insurance guarantee or corporate guarantee or cross cheque. However, the Bid Security in the form of a demand draft or pay order would also be acceptable.
	The Technical Bid submitted by each Bidder (if the Bidder is a Consortium, the relevant Consortium Members) must be accompanied by a Bid Security having a minimum amount of PKR 8,500,000/-
Double Shift	The Morning Shift and Evening Shift operating as per the Facility Timings notified by the Authority from time to time through notification.
Evening Shift	The shift that will operate in accordance with the Facility Timings notified by the Authority for Double Shift, which will accommodate students from Class VI – Class VIII unless otherwise agreed by the Parties during the Concession Period.
Key Staff	The professionals (including Contract/Compliance & Accounts Manager and Education Expert, each qualifying the minimum education and experience requirements) proposed by the Bidder in its Technical Bid to undertake, oversee, and manage the Project's activities on a dedicated and regular basis under a specified Package in accordance with the job description, as may be amended by the Authority from time to time, during the Concession Period. For the purpose of clarity, the Bidder shall propose a separate Key Staff for each Package under which the Bid is submitted to qualify for the Eligibility Criteria. These professionals will be hired exclusively for this project, any existing staff of the Bidder will not be eligible to draw salary under the budget head of Salary of Key Staff.
Morning Shift	The shift that will operate in accordance with the Facility Timings notified by the Authority for Single Shift, which will accommodate students from Class ECE – Class V unless otherwise agreed by the Parties during the Concession Period.
Single Shift	The Morning shift operating as per the Facility Timings, notified by the Authority from time to time through notification.

3. DEFINITIONS AND INTERPRETATION

3.1.1 **In this Agreement**, unless the context otherwise requires, the following terms shall have the following meanings:

"Bid Due Date" means the revised date on which the bidders were required to submit their Bids for the Project in accordance with the Request for Proposals.

"Bid Price" means an amount equal to PKR _____(Pakistani Rupees _____) in present value terms and PKR _____ (Pakistani Rupees _____) in nominal value terms.

"Bid Security" means the pay order/ demand draft/ bank guarantee for an amount equal to PKR 8,500,000/- (Pakistani Rupees eight million five hundred thousand) as details set out in **ANNEX XIV** (*FINANCIAL MODEL*).

"Reappropriation" or "Realignment" stands deleted.

Note: All the other terms and conditions, except those mentioned in this Addendum Document No. I, set out in the Request for Proposals document shall remain the same/ unchanged.
